M&M has also and ran a program of 8 webinars during the past year which have been well attended and positively reviewed by attendees. The M&M has been involved providing advice on a survey of police officers in Ontario regarding their views about traffic enforcement. M&M has also ran a campaign to seek volunteers for the various CARSP committees.</p> <p>As a member of the Structure and Governance Committee I have worked with other members to revise the Board Manual.</p> <p>I am also a member of the Executive Committee and have participated in numerous meetings regarding a variety of issues important to the future of CARSP.</p>

<p>What is your vision for CARSP's future and what do you hope to accomplish over the next year? (200 word maximum)</p>	<p>With respect to the next year, I would like to increase CARSP's membership to at least 700 members and seek more members from regions with relatively few members (e.g., Maritimes).</p> <p>Given CARSP's vision and mission, I would like to see more governments and non-governmental organizations adopt the United Nations' goal of reducing fatalities and serious injuries by 50% over the next 5 years.</p> <p>While CARSP has a formal partnership with ITE Canada, I would like to see more of these partnerships so that we can collectively work to improve the level of road safety in Canada.</p> <p>I believe that CARSP should conduct a survey of our members to determine their satisfaction with what CARSP has been doing since the last survey was conducted several years ago and to determine what they think CARSP's priorities should be in the future. The results of such a survey will provide some guidance when CARSP prepares a new strategic plan</p> <p>I would like CARSP to secure funding from federal and provincial governments as well as the corporate sector to support its' various activities year round and not just for the CARSP conference. This funding could support research projects, workshops, student scholarships, among other activities.</p> <p>I see my major job as VP is to support CARSP's President.</p>
